***How do we obtain your personal information?***

## **What information do we collect?**

Information that we may collect from you includes personal information. This will include information such as your name, your child's/children's name/s, date of birth, email, telephone number, medical & health information, bank account details, home address and information relating to personal circumstances.

Data protection law recognises that certain categories of personal information are more sensitive. This is known as sensitive personal information and covers health information, racial or ethnic origin, religious beliefs or other beliefs or a similar nature, political opinion, and trade union membership. We would only collect sensitive personal information where there is a clear need to do so. Before collecting any sensitive personal information about you we will make it is clear to you what information we are collecting and the purposes for collecting this.

## **How do we use your information?**

We use data collected in the following ways: To process and manage:

- Enrolment (Theatre school).
- General enquiries.
- Use for marketing emails (if requested) regarding appropriate events/ offers.
- Safeguarding of children (Theatre School)
- For emergency, health and wellbeing contact for your child/ children.
- To maintain your contact details in regard to an upcoming booking (applicable to events booked with us).

In all instances, we endeavour to use your personal information to give you the information, support and services that you ask for.

We use your information to keep a record of your relationship with us and for internal administrative purposes (such as our accounting and records), and to let you know about changes to our services or policies. We use your personal information to investigate, and respond to, complaints, legal claims or other issues.

## **Communications**

With your consent, we may use your information to send you communications specifically designed for the purpose in which we obtained your data.

## **Who do we share your information with?**

We will not sell your details to any third parties. We may need to share certain information with trusted partners including local authorities (for instance for safeguarding, and/or licensing purposes) in order to carry out certain professional obligations.

We will share your information if we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and terms and conditions of hire and other agreements; or to protect the rights, property, or safety of children/young people, customers, or others. For instance, we may also share your information with the emergency services if we think there is a risk of serious harm or abuse to you or someone else.

In processing any financial transactions, we may send your details to, and use information from credit reference agencies and fraud prevention agencies.

When we collect your personal information we use strict procedures and security features to prevent unauthorised access. However, no data transmission over the Internet is 100% secure. As a result, while we try to protect your personal information, Performers cannot guarantee the security of any information you transmit to us and you do so at your own risk.
